## BSoA Exhibition Entry Guidelines

- a) Must be a **current member** to exhibit.
- b) Up to 6 entries of original artwork may be submitted by any member for approval by the jury (if a juried show) whose decision is final. Entry fee is **\$10.00** per item. The entry fee is refundable if artwork is sold at the show. Students will be charged **\$10.00** per entry. Fifty percent of the work submitted must be for sale. **No refund will be given for items not accepted in a juried show or if not sold.**
- c) All paintings must be securely **framed** with **screw eyes inserted** and a cord **or wire attached**.
- d) Work which has been submitted to shows before is **not admissible again**.
- e) Entries once accepted for the exhibition are NOT to be removed from the Gallery during the period of the show except when sold to a departing visitor. All works once hung are to remain as placed. Artists may not interfere with their work once it has been hung.
- f) **Entries must be brought to the Gallery at the time and on the day specified.** All exhibits must be removed promptly at the end of the show. Items left beyond a week after closing of the exhibition will be to **subject to a Fine of \$10 per week per item** after the first week. **The BSoA is NOT liable for any damage to items left at the Gallery after this time. - g) The Society of Arts receives a commission of **30%** on all sales from Member's Shows, and 10% from sales made once the work leaves the Gallery.
